Learners New in City with an EHCP

For those learners who arrive to the city with an EHCP issued by another Local Authority the child should continue to attend the educational setting named in their EHC Plan. However, where this is not possible (for example due to the distance which would need to be travelled) there is a requirement for the learner to attend a

setting similar to that named on the plan temporarily until the EHC plan can be reviewed and formal consultations can be carried out.

- All Learners with an EHCP will need an annual review focused on their phase transfer
- This may require an additional (interim) review of the EHCP to be held
